Ingestion: Swallowing can result in nausea, vomiting, diarrhoea, abdominal pain and bleeding. Can cause chemical burns to the mouth, oesophagus and gastrointestinal tract.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

7. HANDLING AND STORAGE

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.
